# CONTINUOUS ENROLLMENT & FAMILY MEMBERSHIP DURING THE SCHOOL YEAR TERM

Remember, by enrolling for the school year term, you're signing up for continuing 4-week sessions that automatically bill and charge you. If you've joined mid-session on a proration, the billing cycle will *still run automatically* unless you've made special arrangements in our office to avoid this. Be mindful that our billing auto-posts one month early to allow you to see the upcoming session charges, and then charges automatically on the 15th for this next session. Therefore, If you join mid-month/session, you may need to pay for the following month as well. Additionally when you start with PowerKids, there's an annual family membership fee of \$60, typically added within the first month of joining. To avoid any surprises, adjust your start date to the beginning of a new session (found under calendar on our website), or make custom payment arrangements within our office. Auto billing becomes a breeze after your first month.

### **TUITION AND REOCCURRING BILLING**

For maximum efficiency and convenience, a card on file is required for class participation. We ask our families to have an active credit or debit card on file, and will be auto-drafted for the next 4 week monthly session on the 15th of each month.

For those wishing to not be on reoccurring billing and autopay, you can self-manage and pay your account online through your customer portal, over the phone at 760-346-4446 or in the office (when available) **on or before the 15th** of the month prior to your class enrollment.

# **CHARTER FUND POLICY**

Enrichment Certificates must be submitted before the 19th of the month for the following session's tuition. Be sure the tuition amount on the certificate matches your enrollments at PowerKids Center. Enrichment certificates should be dated with either the exact session dates or the month that the majority of classes take place. ALL certificates must be submitted through email at office@powerkidscenter.com

No discounts or prorations can be applied for Charter Fund Enrichment Certificates.

### **DROP POLICY**

Class enrollment is continuous for the school year term. We do understand how busy families may need flexibility to come in and out of sessions here and there. To keep our office running

smoothly, anyone dropping from class mid term will notify PowerKids Center via email at office@powerkidscenter.com by the 1ST of the current month to stop the auto-draft on the 15th for the subsequent monthly session. This 15 day notice gives PowerKids office staff appropriate time to terminate the auto-draft, adjust staffing and give the spot to a new student. It is mandatory that all notifications of drops are done via email so there is a written and dated record of your request (office@powerkidscenter.com). Additionally, you may request to drop class via the portal as a secondary (but not replacement) way to alert the office to your intension to give up your class spot. While we keep a flexible policy for coming in and out of classes, we also cannot guarantee you availability upon your return since our classes can and do fill up.

#### **COMPETITIVE TEAM POLICY**

#### **ACH AGREEMENT**

I hereby voluntarily waive any and all claims resulting from ordinary negligence, both present and future, that may be made by me, my family, estate, or heirs.

Further, I am aware that gymnastics, cheerleading, dance, tumbling, trampoline, and fitness are vigorous sporting activities involving height and rotation in a unique environment and as such they pose a risk of injury. The risk of harm may be limited by all of the safety equipment and trained coaches, but never eliminated. I understand that gymnastics, cheerleading, dance, tumbling, trampoline, fitness, and related activities always involve certain risks, including but not limited to, neck and back injuries, injury to virtually all bones, joints, muscles, and internal organs, and the mats, pits, and other safety equipment and apparatus provided for my protection including the active participation of a coach or teacher who will spot or assist in the performance of certain skills, may be inadequate to prevent injury. I understand that participation in gymnastics, cheerleading, dance, tumbling, trampoline and or fitness, including moving from event to event, conditioning, stretching and other activities which may leave me and or my child or children vulnerable to the reckless actions of the other gym participants who may not have complete control over their actions or who may not see other students in the gym. I am and or I am having my child or children listed above voluntarily participate in gymnastics, cheerleading, dance, tumbling, trampoline, and or fitness with knowledge of the risks involved and hereby agree to accept any and all inherent risks of property damage or personal injury.

I further agree to indemnify and hold harmless PowerKids Sportsplex, Inc, and all others listed for any and all claims arising as a result of my engaging in or receiving instruction in PowerKids Sportsplex, Inc, activities or any activities incidental thereto, whenever, wherever, or however the same may occur.

I understand that this waiver is intended to be as broad and as inclusive as permitted by the laws of the state of California and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be within the state of California.

I affirm that I am of legal age and am freely signing this agreement. I have read this form and fully understand that by signing this form, I am giving up legal rights and or remedies which may be available to me for the ordinary negligence of PowerKids Sportsplex, Inc, or any person listed above.
